

MARSHAL REGULATIONS PARKING COMBES

- 1) The Parking "Combes" area is only reserved for the trackmarshals, pitmarshals, and other organizing safety people.
It is strictly forbidden to stay permanently on this trackside at "Combes" or to exercise any professional activity.
- 2) You can only park your caravan or car on the site of "Combes" if you are in possession of an official carpass, authorised by the circuit or organiser.
The request for a carpass has to be done in advance, signed by an authorized person who will forward the request to the Circuit
- 3) It is forbidden to park a trailer, caravan or mobilhome without license plate or not insured. or any other vehicles which are not in possession of a pass,
Never stock inflammable products inside them.
- 4) You can only drive inside the Circuit of Spa-Francorchamps or in the parking des Combes with a car in possession of a license plate and insurance. The driver must hold a driving licence.
- 5) Speed limit on site is 30 km/h (20 miles)
- 6) It is forbidden to built an open air kitchen.
- 7) Any changes to the standard infrastructure are not allowed.
Like deriving electricity or water, adding electrical panels. The power supply is limited to 16 AMP. Spot checks will be done by the works & maintenance dept, of the Circuit any abuse will be punished
- 8) For security reasons, children must always stay under supervision of their parents.
- 9) Everyone is asked to respect and maintain the cleanliness of the sanitary at disposal.
- 10) Everyone is asked to act as a good father and to respect the other users of the parking, Politeness must be applied at any time,
- 11) Pets are only allowed if they're under the lead of their owner. Always clean up the excrement. Any abuse will result by the expulsion of the animal. The reglementation of the cities Stavelot and Malmedy apply for the dangerous dogs.
- 12) Due to the specific activity of the marshalls, consumption of alcohol during the day is strictly forbidden during the day and must be limited in the evening. Any consumption of drugs is strictly forbidden and will result by the exclusion of the person.
- 13) The "Combes" parking is a rest area... After 8pm please limit the noise
After 10pm, no noise should be done
- 14) The circuitpass must be visible at all time on your windshield.
Every caravan / motorhome without the circuitpass will be removed.

- 15) Every caravan must be mounted on his stuts in balance. The caravan and the area around must be clean, It's forbidden to throw away external waste in the container of the Circuit
- 16) Every vehicle must have it's carpass from the Circuit or from the organisor. The car must be parked next to the caravan. No vehicles are allowed inside the Circuit without a valid carpass.
- 17) It is forbidden to let external people enter via the gate of "Combes".
A security camera will be installed, every infraction will be punished.
- 18) In case of issues or emergencies, please dial 087 / 56 16 23
- 19) Every user of the "Combes" site must be insured against fire, theft for their caravan and also be insured for damages caused to others
- 20) This reglementation is approved for 2015. The circuit has reserved his right to make updates
- 21) As a reminder the use of the "Combes" area is temporary approved by the Circuit, this autorisation may be ended at any time without any compensation
- 22) Everyone must respect the rules of the Circuit and i'ts staff, the concierge and accept by using the parking of the Combes the authority of Protection Unit and the responsible persons of the BTM and ACSF
- 23) In particular, the signers of this document are empowered to enforce these rules.
